Last month Pope Benedict the 16th spent a good deal of his time backpedaling from comments that he made at the University of Regensburg regarding Islam and the Prophet Muhammad. For those of you who missed it, the pope quoted from comments made by a 14th century Byzantine Emperor, Manual II Palaeologus, who had asserted that Muhammad's teachings were evil and inhuman, "such as his command to spread by the sword the faith he preached." Pope Benedict reiterated Manual's assertion that proselytizing faith by violence was unreasonable and he commented that, "Violence is incompatible with the nature of God and the nature of the soul."

Response from the world of Islam was nearly instantaneous. Muslim spokesmen rushed to the media with comments like: "Islam is a religion of peace and reason" and the pope "aroused the anger of the whole Islamic world and strengthened the argument of those who say that the West is hostile to everything Islamic"

I am just incredulous that someone with influence finally got the nerve to point the finger at the Muslim world and tell them that they need to clean up their act, only to have the accuser retreat, cowering and apologetic, over shining a light on something that should be clearly obvious to any thinking person; Islam is being used as a tool to wreak havoc almost everywhere in the world. Think about it. When you hear the terms "*jihad*" and "holy war", what religion and what peoples immediately come to mind? It borders on the surreal to live in a world in which it is politically incorrect to implicate Islam in a world wide terrorist movement that recruits its henchmen and promises heavenly rewards, all in the name of Allah. Allow me to suggest that the world take off its rose colored glasses and start facing reality.

I know that I am stepping into a minefield here; after all, the United States has a storied history of protections for religions and religious freedom. So understand that I am not accusing the Islamic religion of being responsible for the innumerable acts of terrorism that are being perpetrated by these fanatics. I am sure that Islam has attributes similar to all of the other great religions of the world. What I do intend to say, however, is that the Muslim world is clearly not doing enough to dissuade the extremists from committing their acts of violence against a civilized world.

Islam, unlike the Catholic Church, does not have a hierarchy administering to its practitioners. That does not mean, however, that there is no organization to the religion. Islamic scholars provide guidance to Muslims and, depending on the nation and the sect, there are clerics, muftis, Imams, ayatollahs and even Muslim brotherhoods who carry a great deal of weight with their Islamic brethren.

When the pope made his speech in Regensburg, there certainly was no dearth of Islamic leadership to run to the media and defend the nonviolent nature of Islam. If Islam really is a religion of "peace and reason", I have to ask; where are these scholars every time an Islamic extremist kills a multitude of innocents under the guise of *jihad*? Why aren't they rushing to the media to denounce the murderer and those who instigate his actions?

The answer to my question is almost certainly political expediency. It is conceivable that these leaders are in favor of trying to hold back the tides of modernism, and that certainly seems to be one of the goals of the Islamic terrorists. Further, I imagine that changing the mindset of their followers would be a tough battle to undertake, would risk alienating their constituency and these religious scholars may feel that it is in their best interest to just let the butchery continue. I do not believe that "the West is hostile to everything Islamic," but by not actively striving to curtail the violence, these leaders and spokesmen of the Muslim world risk creating a schism with the West that may generate just such a hostility.

The situation is certainly much too complicated to predict how it will play out. It seems to me, however, that at some







## SNORIN' IN SONORA TOUR



I awoke the Saturday morning of the tour with anticipation and trepidation. train cars linked together. As if to enhance the train yard ambiance, the ground started shaking and a train went right by the back of the restaurant at seemingly breakneck speed. After that little adrenalin raiser, I went outside to inspect the nearby track and found it to be only 20 feet or so from our dining room. I'm sure glad the train decided not to derail while we were dining!

After our meal, the restaurant owner took pictures of our cars as we departed and we began the relatively uneventful last leg of our drive to Jamestown. I have driven nearly all of the eastbound routes from the central valley, but had never driven the Bryant's route east of Turlock: mostly over county roads J17 and J59. I encountered odors and a lot of vibration along the way, however. We passed by a few cattle ranches and the methane gas was plentiful. We arrived at the Royal Carriage Inn about fifteen minutes early, and after we managed to squeeze into the narrow, long parking lot, the Bryants handed us our room keys. Known as "The Movie Railroad," Railtown's locomotives and cars have appeared in over 200 film and TV productions. As a bonus, that particular Saturday was devoted to a benefit event for raising money to restore some of the trains. A wonderful trio consisting of native American drums, wooden flutes, and a guitar were playing indigenous music from north and south America. This engaging music convinced me to pry \$15 out of my wallet for a CD.

I seldom refuse the grape, especially when the label says Cabernet Sauvignon. After I settled back in my room, I had a chance to dig into the Bryant's trip folder. Talk about complete! Besides the usual snacks and tour instructions, there was a list of contact numbers, room assignment names matched to room numbers, a September/October events calendar, a history of Jamestown, and a crossword puzzle based on song lyrics from the 60's and 70's.

We sauntered over to the National Hotel for dinner in the back room. I had the pleasure of dining with the Bryants, Morgans, and Illes. I apparently chose the right table, because the Morgans seem to be wine buffs. They appeared to be well stocked with wine for sharing during the party phases, and chose a couple of good bottles for our table at dinner. Two bottles for the seven of us was rather sufficient. Some of our group was starting to feel sorry for the other diners as the volume of our presence became elevated. Elevated decibel levels in a good-time gathering? Is that possible?

It wasn't long after I returned to my room that I heard boisterous activity on the back porch. It appeared to be a reprise of the afternoon's happy fizzies party. Yes, again I partook of the grape while listening to Bob Morgan serenading us with his mandolin while Jim Bryant and I chimed in on some of the songs unearthed from the 60's and 70's. I was amused at Ken Illes' first-aid kit, consisting of some whisky, seltzer, and even a little metal widget that squeezes lime into your drink.

The following morning, we all had breakfast in the adjoining library room, courtesy of the proprietor. Some of the group decided to go to historic Columbia. I decided to drive east of Sonora about 30 miles to Pinecrest Lake, where I hiked the perimeter of the lake. The area from there to Sonora Pass provides many pleasant memories for me, because this is where my parents and I vacationed for many years starting when I was five years old.


