In September of 1966, a new program debuted on NBC. It faltered in the ratings and within three months the suits at the network announced plans to ax the show from its schedule. Thanks to the efforts of thousands of fans who flooded NBC's offices with protests, the show was saved and managed a run of three years. The show?; Star Trek, of course; a show which, even after its network demise, continued to generate new fans and a cult status that spawned no less than four successful successor series as well as a spate of eagerly anticipated and profitable feature films.

Being a science buff, a science fiction buff, male and in my mid teens, I'm sure that I fit snugly into this show's demographic target audience and it was must viewing for me every week. Even years later, I continued to watch the show in reruns as its novel mix of alien life forms and cultures, technological speculation and human drama held up nicely over multiple viewings.

In the world of art there is an aesthetic theory called "suspension of disbelief". It refers to the audience's willingness to accept the fantastic, or even the impossible, in a work of fiction. Needless to say, suspension of disbelief is integral to success in the sci-fi genre. While this willingness is given readily by the reader or viewer, it is not something to be abused and when abused, the suspension of disbelief can be instantaneously withdrawn, thereby sinking the story. I recall a particular episode of Star Trek that has stuck with me over the years precisely because my suspension of disbelief crashed over a piece of technological tampering that seemed too far fetched within the story (created in the 1960s) yet seems to be happening in the real world today.

The particular episode that I have in mind was in essence a court room drama in which Captain Kirk was accused of ejecting some ship's device from the vessel without following proper procedure and thereby killing a crewman in the process. Despite Kirk's emphatic assertion to the contrary, the Enterprise's bridge video log clearly showed him as being guilty of the charge. The episode was resolved by the intrepid captain when he managed to prove that the missing crewman had born a grudge against him; was in fact still alive and hiding aboard the Enterprise; and that, and this is where the show lost me, in his effort to bring down Kirk, the bridge video logs had been altered by the vindictive miscreant to show the nonexistent transgression. My analogue mind was just completely unable to accept the notion that one could convincingly and untraceably manipulate moving images to alter the perception of what had actually been recorded.

This was all brought back to me recently when I sent a video clip to my son that showed a kite surfer being caught up and, presumably, killed by a passenger jet as it was landing at a beachfront airport. Because of my dour nature, I have often advocated that folks need to be more cynical in nature (I suppose the more upbeat folks could just be more skeptical) but I was almost shocked when my son emailed me in response to the video clip saying, in essence, that he didn't believe it and that he thought that the clip had been "edited".

I have always tried to be very careful about accepting what I see and what is sent to me on the computer. I always question assertions of unverifiable fact, even assertions of authorship, and tend to disregard them without some confirmation from a more reliable source. I have even accepted that static images can be readily altered, or "photoshopped," and tend to view the more outrageous images with a fair degree of skepticism. It was not until the email from my son, however, that it occurred to me that I may now need to start being more cautious in accepting the veracity of unsolicited video images that I may view or receive in this digital and computer "toolbox" compliant world.

I have viewed the suspect video repeatedly and am still of the opinion that it has not been edited. Whether it has or not is of no importance. If you're interested, send a request to badass@ix.netcom.com and I'll send it to you so you can judge for yourself.

Kudos to the late Gene Roddenberry, the creator and writer of Star Trek, for his bold, almost prescient, prognostications regarding the evolution of technology. Kudos also to my son, for his skeptical reaction to the video, which has pointed me at an entirley new venue toward which I may now direct my cynical outlook.






"I don't care how cold the food gets... I'm not taking a bite until you put away the damn camera," says Karen Tefankiian.

OK, OK, OK – so now it's time for me to collect my prize... drum roll... the number







Our First Rallye

"Car Rallies? What's that all about," I thought to myself when the subject was brought up when I first joined Monterey Bay Region Porsche Club of America way back in 1970.

I had just bought my very first Porsche, a gorgeous brand new 1969 champagne yellow 911 T Sportomatic, this decision being spurred on by a good friend who



had a 911 himself and was already a member of that region. A momentous decision for me that has had an effect on my life for the last 37 years in PCA, not only for the wonderful cameraderie that being a member has offered all these year, but also because at that time the \$7,300 price tag was a mighty high price to pay for any automobile. Even then it took six years to pay it off. But I digress.

And so, along with enthusiastic involvement in all other events offered, my wife and I decided to try our first rallye. We had no idea exactly what was involved, and only a rudimentary coaching in what we were supposed to do. "Just do it" we were told, and that we would learn from the experience. We didn't even realize that the timing of each minute was split into 100ths rather than 60ths. At least we completed the rallye without getting lost, and to our utter amazement when reaching the final check point at Moss Landing we were told that it appeared we had done pretty well. Further checking of our score sheet at the end of the rallye, it was revealed that we had not only won the rallye, but had a darned near perfect score!

Needless to say, my wife and I were pretty pleased with ourselves, and as unknown newcomers to the region, everyone there thought we must be rallye whiz-kids and gave us a lot of totally undeserved respect. Our protests that we were just darned lucky fell on deaf ears, for even most rallye winners don't get perfect scores, just the best results of the bunch.

Now armed with a reputation for success, but knowing otherwise in our hearts, we decided to go to rallye school. Just so we could perhaps do reasonably well next time and perhaps maintain our reputation. Even though the rallye instructor was one of the best in Northern California, this course of instruction caused our undoing. All the pitfalls pointed out and little rallye tricks were explained. One I shall never forget was that general instructions superceded the route instructions. This was reasonable enough in itself, since some of these many general directives said self-obvious things like "exhibit courtesy on the road to others", or "drive carefully and don't take chances", or "anyone found drinking alcohol on the rallye will be disqualified", or "obey posted speed limits", or "there are no spelling errors", etc. etc.

And so dismissing these things as being relatively unimportant and just good public relations intended, we proceded with our route instructions.

"Zero odometer. Right out of parking lot, right at 10.3 miles. Left at tee. Left on Wolfe Road. Right first chance. Left at 23.7 miles. Right at stop. FLR (follow lined road) for 30.1 miles", etc. etc. Everything was going just fine and we thought we were doing O.K. until we finished the rallye and the critique. Our scores were terrible. We had been way off course and didn't even know it, for the wiley rallyemaster knew that some people would

get off course at a certain trick instruction, but further route instructions would bring them back on course without them even realizing they had been lost. And the trick? Simply the route instruction - "Right first chance". We had forgotten (or ignored) the superceding general instructions that included ".....don't take chances"! So we should have ignored that instruction. Needless to say there was much gnashing of teeth, groans, and pulling hair. Even another instruction was a trick one. "Left on Wolfe Road" seemed quite O.K. when we got there, but we didn't notice that the road sign we had turned at was spelled "Wolf". Another lot of groaning when it was pointed out that there were no spelling errors, and that we should have ignored the Wolf Road instruction.

So from now on we laboriously scanned and looked for any hidden meaning in any rallye instructions. We examined all sorts of possible meanings, subterfuge, and on the whole we doubted everything we saw. The whole thing had become more of a challenge one would expect from smart lawyers in a court of law rather than a sports event. It became so arduous for us that we frequently argued over the instructions, before and during the rallye. This was not fun, and certainly not what a rallye is supposed to be. Solution? We swap navigators at the start with other willing participants. It's surprising how someone other than your own spouse gets respect under these circumstances, politeness reigns supreme, and everyone is happy, - win or lose




