

Do you remember the Laffer curve? It was a hot topic during the early years of the Reagan presidency. It was espoused by Arthur Laffer, purportedly illustrated on a napkin, in a 1974 meeting with none other than Dick Cheney, who was then a Deputy Assistant to the President of the United States. The Laffer curve was based on an economic theory of the elasticity of tax income based on a tax rate ranging from 0% to 100%. It posited the theory that the tax proceeds would be zero at both ends of the spectrum; zero at the low end because zero percent of anything is zero, and zero at the high end because there would be no incentive to have income if it all went to the government. Cheney fully embraced this economic truism, carrying it deep into the conservative movement where it became a major brick in the foundation of the supply side economics approach to government that was a hallmark of the Reagan administration. Reagan's view of taxes and the economy were dubbed "voodoo economics" by a Republican opponent, but the new president had the last laugh when he successfully cut tax rates and resultant government revenues blossomed. Reagan's success in cutting taxes and arguing for smaller government set the standard for decades of politics to come and enabled the conservative surge that allowed the Republican takeover of both houses of congress.

So why bring up the Laffer curve in 2008? It's because the concept is a financial one that does not only apply to taxes and government. In fact, I think it is used extensively by corporate America, and especially so in reference to the price of gasoline.

Have you ever wondered why the retail price of gas fluctuates so wildly? I have... a lot. There is no doubt in my mind that the oil industry is constantly analyzing the price of crude oil, refining capacity and demand to calculate the sweet spot for the retail gas price that will generate the most profit for the company. They have already gimmicked the market by not undertaking expansion of refining capacity. This way they can claim that the price fluctuations are based on demand; prices have to go up so we don't overshoot the industry's limited production capabilities. As a not unexpected result, individual oil companies now report ten billion dollar quarterly profits with regularity. But even within these constraints, the Laffer curve is at work. The companies know that at a certain price, people will begin to look for alternatives to drive less and the oil profits will go down. So they constantly raise and lower prices to keep the consumer used to the volatility as they tweak their price structure to maximize profits and keep those ten billion dollar quarters rolling along.

What really put me on to this analysis was the election of 2006. There was a proposition on the ballot to enact a tax on gasoline to fund alternative fuel research to lower our dependence on fossil fuel. Strangely, gas that had been selling for \$3.50 a gallon during the summer was a mere \$2.20 on Election Day. Although the price rose 7 cents a gallon on that very day, the voters had already succumbed to big oil's scary predictions of a huge bureaucracy with a fuzzy mandate and the measure failed to pass. Today the price is back up to \$3.50 a gallon.

So what is an ordinary guy supposed to do? My suggestion is to embrace the Laffer curve! The next time a gas tax comes along, vote for it!

#### POST Positions...

You see if the Laffer curve is valid, then that sweet spot for the price of gasoline is valid also, and it doesn't matter to whom the funds are flowing. If the price of gas at \$4.00 is high enough to cause the consumer to seek alternatives and stop buying as much gasoline, the oil companies will have to keep the price at \$3.50 whether there is a tax built into it or not, because from their point of view, *they must keep Americans hooked on oil*. If the new tax sends 2 billion dollars per quarter to a new bureaucracy, that oil company will just have to report a paltry 8 billion dollars as their quarterly profits. Unless you are an investor or an executive in an oil company, this is the closest thing there is to a sure thing!... even a bureaucracy with a fuzzy mandate has got to accomplish something that would encourage changes. Remember... it was General Motors' cancelled EV1 electric car project that scared Toyota into creating the Prius hybrid. Since none of these companies can afford to be left behind, they'll have to take steps to accommodate change.

It is probably a pretty universal trait for citizenries to be skeptical of their governments, especially when it comes to the enabling of taxes on their everyday lives. In this case, however, I think it behooves the voter to bet on the tax... and fuzzy mandate or not, I'd rather see a new tax funding a ponderous bureaucracy stumbling around looking for alternatives than have the oil industry continue to generate Brobdingnagian profits with no greater goal other than self preservation.


