There were two interrelated stories in the paper recently relating to jobs. The first was a story about Measure E on the San



Jose ballot; the "Opportunity to Work" law. It told the story of Blanca Rodriquez, a mother of three and part time employee at a local fast food chain who has watched her manager hire several part time employees while refusing to grant her more hours; Rodriguez claiming, in reference to her children, "I can use the extra money to buy them food, shoes or clothes." The second story was about a startup business in Mountain View, Zume Pizza, that is a delivery-only operation that makes fresh pizzas using robot labor (a pizza made in 22 seconds!) and then bakes them on the road, in the delivery truck, in smart ovens.

I had some blood taken this week and in the phlebotomist's work area was a labor law poster on the wall specifying a \$7.25/hr. federal minimum wage. In San Jose the minimum is \$10.30/hr. There is a strong progressive movement nationally to up the federal minimum wage to \$15.00/hr., as has been done on a local basis in some municipal areas around the country. Couple this trend with the cost of providing mandated health care benefits to employees who work over 30 hours a week and you can see a justification for a company to not want to give more hours to part time employees, or even, as in the case of Zume, not have employees at all.

I am amazed every time I hear an advocate of higher minimum wages say that it will not reduce jobs. Almost all fast food franchises now just give you a cup when you order a drink and you then fill it yourself. The company suits realized it was cheaper to give their patrons all-you-can-drink beverages rather than to pay someone to fill the cups. These same franchises are creating and pushing order-on-line apps, and why?... because it eliminates paying an employee to take the order. I've seen pictures of a McDonalds franchise with computerized order stations at the counters, seemingly to experiment with the same concept in the store. Grocery stores and the big hardware chains are using self-checkout to eliminate clerks from their payrolls. But the progressives ignore the obvious and just continue to pander to their constituency by pledging to increase their income through federal fiat with no risk of adverse consequences.

Rodriguez is in a tough place. Frankly, I am in full agreement with the goal of Measure E. Our nation, thanks to Obamacare, has decided to mandate that employers provide health care to their employees. Like it or not, it's the law

and these large scale employers have figured out a way to circumvent that mandate by using part time help, hitting their work force with the double whammy of fewer hours and no benefits. This is the antitheses of what was intended by the legislation and a perfect example of unintended negative consequences precipitated by good intentions. It is patently unfair to the working poor and is a further demonstration of the excessive power that corporations hold over their labor force.

I wish that I could vote for Measure E... but I can't, for two reasons. The first is easy: Measure E exempts government workers. I just can't abide the hypocrisy of a bureaucracy enforcing employment protocols by which they, themselves, do not have to abide; if the measure is right and proper for private business, why isn't it good enough for public employees? The second reason is more complicated, but amounts to the fact that regulation of business is becoming so onerous it is increasingly difficult for these companies to cope with changes in the economy and business trends. In the 1980s, the U.S. was the envy of the world with our ability to pivot on a dime reacting to changes in the world economy. Regulatory bloat and worker's rights legislation/litigation have made adapting to change so sluggish that many businesses now hire reluctantly, preferring contracting for workers rather than putting them on their payroll. Bureaucratic meddling in hours allocated to employees would be just another brick added to this burden on private business.

Is there a more palatable solution to this dilemma? If the Progressive's goal of doubling the federal minimum wage is likely to occur, I would like to suggest that the change instituted also fix Rodriguez's problem at the same time. Eliminate the 30 hr. limit for benefits for workers earning less than, say, \$20/ hr. and create a federal minimum wage of \$12/hr. if the job pays full benefits and \$15/hr. if it doesn't. Index it for inflation and you're good to go. This solution eliminates the financial incentive to maintain a part time workforce,

but of course has a few downsides, to wit: a worker in, say, Kingman, Arizona would probably feel like it was raining money, while a 40 hour per week employee in some Bay Area markets couldn't afford a 1 bedroom apartment. Also, doubling the minimum wage will surely spawn more automation, ala Zume Pizza, and a further erosion in the number of low skill jobs.


